## Terms & Conditions

Receipt of a signed copy of this order form will be deemed acceptance of these Terms and Conditions.

- All prices exclude GST.
- All items are on a hire basis only.
- All items will be the responsibility of the client whilst in their care. Any damage or loss of any items will incur charges and will be charged at the full retail value of the stock item. This includes decorations, garlands, wreaths, props, lights and trees.
- The client is to provide a safe two-socket electrical supply handy to the desired location of the tree. Any extension cords or taping or cord coverage will be the responsibility of the client. Single-light transformers will be supplied – these will have current test and tags for the duration of the hire.
- All trees, decorations, garlands, wreaths or props are for indoor use only. Any damage from excess sun or use outside will be charged at the full retail value of all stock.
- An invoice for the order will be issued on 1 October 2026. The invoice is confirmation of the client's order. If the client cancels their order after the invoice is issued, a 50% cancellation fee will apply.
- If the invoice is not paid by 1 November 2026, the client's order will be cancelled, and a 50% cancellation fee will apply.
- All invoices are to be settled in full before any install commences.
- Whilst we take all precautions to install the tree with full working lights and ensure the lights are working through the hire period, sometimes circumstances outside our control result in the lights failing. We will ensure their working order before leaving the site after installation. Extra charges will apply to return and replace non-working lights during the hire period.
- All of our trees are unique and specially created for each client; the design of each tree is considered. If a client does not like the design or decoration choice after installation, a fee to return and change the decorations, on a suitable date for us, will apply. This fee will also include the cost of travel to the installation destination.
- Once our trees and other decorations are installed, they are not to be moved under any circumstances unless we have provided the means to do so. Any damage due to movement to the decorations, trees, garlands etc. by the client, will incur hefty fines.
- An additional fee will apply to an order if an install or pack-out is required outside of a scheduled installation/pack-out run to the client's town/city. This may incur a surcharge, depending on the location (POA).
- We reserve the right to photograph and film all trees and decorations for marketing purposes. These may or may not be photographed/filmed with tree numbers.
- All 15ft trees require a scissor-lift for installation and removal. This is included in the price of hiring 15ft trees. We need suitable access for this equipment, so please take this into account when planning the tree's location. We take no responsibility for any floor damage resulting in the scissor-lift's safe use.
